Policy Corner

2025 was an eventful and challenging year for farmers and our food system and farmers are facing challenging economic conditions. The legislative year is winding down, with no major changes to federal policy expected between now and January. In November, as part of the deal that ended the longest government shutdown in U.S. history, Congress extended the 2018 farm bill for another year. USDA's funding was extended through September 2026, meaning that funding for agriculture will not be part of any negotiations in

another potential shutdown at the end of January.

Secretary Rollins announced last week that an aid package of \$12 billion would be released for farmers in response to tariffs and rising production costs. The aid is reserved primarily for commodity farmers; only \$1 billion will be available for farmers growing specialty crops. No further details on the payment program for specialty crop farmers has been released as of December 17. Meanwhile, applications for the Supplemental Disaster Relief Program Stage 2 (intended for losses experienced during the 2023-2025 crop years) opened on November 24 with a deadline of April 20, 2026. The SDRP homepage has more information, and USDA has released several webinars on the program.

Have you ever wondered what the best ways to insulate your operation from catastrophe are? If so, Extension Risk Management Education's publication Introduction to Risk Management provides a lens into the top risks farms face and how to effectively mitigate them. Although it's 11 years old, the content is still the most comprehensive and timely that we're aware of!

"AgFTAP" (Agricultural Finance, Tax, and Asset Protection) is a national program providing educational resources and tools centered around strategic business planning and farm financial management. These resources are freely accessible via agftap.org and have been developed for producers as well as ag educators. In addition to resources, users can access a network of ag supporters they call Farm Champions, who can provide support and advice in the farm finance space.

OFRF has launched its National Organic Farmer

Survey, which is conducted every few years and aims to understand the challenges, priorities, and needs of organic and transitioning farmers across the country. The survey is open to all certified and in-transition organic farmers and ranchers

Upon completion, all farmer respondents will receive a code to Johnny's Selected Seeds and have the opportunity to win other farm-related prizes like boots from The Original Muck Boot Company, FELCO pruners, and a consultation for your farm. Food Animal Concerns Trust (FACT)'s Fund A
Farmer Grants are now open through January
3rd, 2026. There are two grants available; you
are invited to apply for both:

- Fund-a-Farmer Welfare Improvement Grants up to \$3,500 each for farmers looking to improve the lift of their animals, pursuing animal welfare certifications, or aiming to maintain current certifications.
- Fund-a-Farmer Systems Change and Innovation Grant up to \$10,000 for farmers seeking to develop business plans/feasibility studies, install infrastructure for pasture-based operations, adopting alternative livestock breeds, or to develop alternative or cooperative marketing strategies.

Fund-A-Farmer grants are highly competitive; if interested, be sure to start early in order to compose a strong application!

Sky High will award \$350,000 in grants (total) to individuals working in agriculture, food justice, and/or land sovereignty. The average proposal funded in 2025 was \$11,000 with grants ranging from \$1,500 up to \$30,000. Grant proposals should match the scope and capacity of the amount requested. Applicants who requested funding 2025 and did not receive a grant may resubmit applications for consideration. The 2026 grants application window is now open through January 20, 2026.

The FruitGuys Community Fund: Applications will start being accepted in December and into January 2026. These grants are up to \$5,000 for farm owners who have long-term land access and have operated for a minimum of two years.

The Farmer Veteran Fellowship Fund is a small grant program that provides direct assistance to

veterans who are in their beginning years of farming or ranching. The next grant cycle will open in January 2026.


The Northeast Sustainable Agriculture

offers competitive Research and Education grants
to farmers, educators, service providers,

others to address key issues affecting the

region. Application due February 2, 2026.
